# **Course Description**

**CJ 1310 Introduction to Criminal Justice** (3). History and philosophy of criminal justice: ethical considerations, crime defined, overview of criminal justice system, law enforcement, court system, prosecution and defense, trial process, and corrections.

#### **Student Learning Outcomes**

Upon successful completion of this course, students will be able to:

- 1) Summarize the historical, theoretical, and philosophical developments in criminal justice,
- 2) Identify and discuss the steps in the criminal justice process,
- 3) Distinguish the goals and philosophies of due process and the crime control models of criminal justice,
- 4) Identify the ethical responsibilities and the constitutional duties of the criminal justice professional,
- 5) Summarize how law enforcement, courts, and corrections operate and interact, and
- 6) Explain the importance of empirical data in criminal justice policy.

#### **CLASSROOM POLICIES**

#### **Class Behavior**

To allow for orderly learning and differing discourse, students are reminded to follow the rules of courtesy during classroom discussions. This is a college course, and student vocabulary and word choice should be appropriate for a college classroom. Students should stay on-topic and handle non-class-related matters outside of class. We will be covering topics that can be socially sensitive; therefore, we must remain respectful of each other's points of view during the course.

#### **Class Protocol**

This is an online class, and students are expected to participate by doing the assigned readings, watching the assigned lectures, and participating in the discussion boards.

This course has 5 modules. Modules 1-4 will run from Monday at midnight to Sunday at 11:59 p.m. Due to the University calendar, Module 5 has a shorter length and will run from Monday at midnight to the end of the course on Friday, June 28th, at 11:59 p.m. All work must be submitted to Canvas by the deadline listed in the Syllabus. No extensions will be granted.

Students should take responsibility for their learning. This also means submitting all assigned material, including but not limited to assignments, quizzes, exams, and canvas discussions, on time. Students are expected to participate in online discussions and activities. Students should seek clarification for any questions they do not understand.

Students are held responsible for all assigned materials. Examinations will be open for one week and must be taken by the due date. There will be no exceptions. Grades are not negotiable and

will be determined by the final point total. All scores are final and will not be rounded up. Every student will have the same opportunities to earn points. Students will receive the grade they earned.

## **Grading Scale**

#### **Syllabus Quiz**

Students will be required to take and pass a ten-question quiz on the course syllabus. Students will be allowed to retake the quiz until they receive a passing score. Students should aim to complete this as soon as possible, as the rest of the course will not open until a passing score is reached. **This will be worth a total of 20 points.** 

#### **Introduction Post**

Since this is an online class and a portion of our learning will happen in online discussion boards, we should know with whom we are discussing topics. Students will write a paragraph introducing themselves. They only need to introduce themselves in one post and do not need to reply to other students, but they are welcome to do so. **This will be worth 10 points.** 

#### **Discussion Boards**

There will be 4 Discussion Boards throughout the semester designed for students to give their thoughts on a topic. They should be completed in academic writing, including source documentation, but first person is allowed. **Students will make an initial post on the topic and must respond to at least one other student.** The initial post should be between 200 and 300 words, and the students will receive up to 15 points for the post. A reply post should be between 150 to 250 words, and students will receive up to 10 points for the required reply post. Replies should add content to the discussion and avoid simple agreement or disagreement with the original author. **Each Discussion Board will be worth 25 points each for a total of 100 points.** 

#### Exams

Exams will be given via Canvas, consisting of multiple-choice, matching, true/false, and short-answer questions. There will be two exams. Each exam is timed, and students have 80 minutes to complete it. Students are allowed to consult their notes and the textbook during the exam but should not consult with other students. Each exam will consist of 50 questions and be worth 100

points, for a total of 200 points.

#### **Criminal Justice Career Presentation**

Students will create a presentation on a Criminal Justice career of their interest. The presentation requirement will be posted in Canvas. The presentation is due to Canvas no later than one week before the end of the course **by 11:59 p.m. on Friday, June 21st**. **It is worth a total of 120 points**.

#### **Extra Credit**

Each exam will also include an extra credit section. No other extra credit opportunities will be given.

#### **Late Assignments and Missed Exams**

Due to the fast-moving nature of this course and its limited content, late assignments and missed exams will not be accepted.

#### **Use of Artificial Intelligence**

Students should not use Artificial Intelligence (AI) in this course. All work should be the student's own product. Using AI will be viewed as an act of Academic Dishonesty.

#### **UNIVERSITY POLICIES**

#### **Academic Honesty Policy**

Students at Texas State University are expected to uphold high academic standards. Texas State will not tolerate a lack of academic integrity.
