### **Course Description**

#### CJ 191. Introduction to Criminal Justice (3).

General education social and behavioral sciences course. Introduces crime and the criminal justice system by discussing the nature of crime and by identifying multiple facets of the justice system, including the police, the courts, and correctional agencies. Studies the role of the criminal justice system as it relates to the individual and to society. Students become acquainted with criminal justice careers. This is a Kansas Systemwide Transfer Course.

### Measurable Student Learning Outcomes

Upon successful completion of this course, students will be able to:

- 1) Summarize the historical, theoretical, and philosophical developments in criminal justice
- 2) Identify and discuss the steps in the criminal justice process
- 3) Distinguish the goals and philosophies of due process and the crime control models of criminal justice
- 4) Identify the ethical responsibilities and the constitutional duties of the criminal justice professional
- 5) Summarize how law enforcement, courts, and corrections operate and interact
- 6) Explain the importance of empirical data in criminal justice policy

### **Class Protocol**

A portion of the grade is based solely on participation. In-class activities and discussions constitute part of the class. In order to have an effective learning experience and to master the material, students should make every effort to attend all class sessions (please note that on the dates that have an asterisk attendance is mandatory). If a student should miss class, it is the student's responsibility to understand what they missed and to get the notes/information from another student. It is not the responsibility of the instructor to re-teach any portion of the class.

Students will be held responsible for all assigned materials. Examinations must be taken on the assigned date at the assigned time. Grades are not negotiable and will be determined by the total number of points accumulated. Every student will have the same opportunities to earn points. Students will receive the grade they earned.

Students are expected to participate in classroom discussions and activities. Asking questions, providing varying perspectives, and discussing the topics at hand make the class much more enjoyable and exciting for everyone. Participation/attendance is mandatory on days noted with an asterisk. Failure to attend on these days will directly affect a student's grade.

Please make sure all cell phones are either off or put on silent. If a student needs to take a call, please exit quietly to avoid disrupting the class discussion or students trying to pay attention.

- Students are expected to prepare for class, read assigned materials before class, satisfactorily participate in class discussions, and turn in required coursework on time.
- Students are expected to take responsibility for their learning. The instructor is not responsible for your learning. This requires your effort.
- Students are expected to submit all assigned material, including but not limited to assignments, quizzes, exams, and blackboard discussions, on time.

## **Class Behavior**

To allow for orderly learning and discourse, students are to follow the rules of courtesy, including refraining from using sexist, racist, off-color, or demeaning language or behavior, sometimes referred to as flaming. This is a college course, and student vocabulary and word choice should be appropriate for a college classroom. Students should stay on-topic, handling

### **Exams**

Due to the number of students enrolled in this course, Exams will be on Blackboard and automatically graded except for short answer questions. Short answer questions will be graded within one week, but usually sooner. Students must notify the instructor before the exam due date if they cannot take the exam. There will be 4-unit exams. Each exam will be worth approximately 100 points. **This will be worth a total of 400 points**.

## **Criminal Justice Career Presentation**

Students will create a presentation on a Criminal Justice career of their interest. The Presentation will be <u>due to Blackboard by 11:59 pm on Friday</u>, <u>December 9<sup>th</sup></u>. Students will be given the details of presentation requirements and a rubric after Labor Day. **This will be worth a total of 150 points.** 

## **Observation Report**

Students will write a one-page observation report after observing a scene for 10 to 20 minutes. Please make sure it is school appropriate. Details about this assignment will be given in our Policing Unit. **This will be worth a total of 100 points.** 

## **Required Class Meetings**

There will be 4 required classes for guest speakers. These people are leaving their workplaces to speak to you about various topics or jobs in the Criminal Justice System. Each required class is worth 25 points for a total of 100 points.

## **Discussion Boards**

There will be 5 Discussion Boards throughout the semester (an introduction post and a topic post per unit). Students will have one week to complete the discussion board from when the discussion post is assigned. These posts are designed to give your thoughts on a topic and

should be completed in academic writing, but first person is allowed. One Initial post (worth 15 points), and One Response to another student's post (worth 10 points) is required (Two Total Posts, unless noted in the discussion board). You can reply to more posts, but you are not required to post on more than one student's initial post. Students should add to the conversation and not just post they agree or disagree. To receive the full possible points, a student should have put thought into the post and thoroughly explained their answer. Discussion Board Posts will not be accepted late under any circumstances. Each Discussion Board will be worth 25 points for a total of 125 points.

## Participation/Discussion

While attendance is not required, participation is required. A total of 125 points of the student's grade will be devoted to participation, with 62.5 points of this grade being assigned at the mid-term point and 62.5 points being assigned at the end of the semester.

### Late Assignments, Missed Exams, and Required Class Meetings

Discussion Posts will not be accepted late under any circumstances. Required Class Meetings with Guest Speakers can also not be made up. Exams may be made up with appropriate documentation; see below. Without penalty, all other assignments may be handed in until 11:59 pm on Thursday, December 1<sup>st</sup>, 2022. No Late Assignments will be accepted after this point.

A missed exam will be allowed to be made up with documentation in the event of an extreme emergency (i.e., emergency medical condition, verifiable accident, death of an immediate family member, etc.) Notifying the instructor of such an event must occur as soon as possible (preferably within 48 hours). Documentation must also be presented to the instructor to make up missed exams. Students missing an exam will be given an alternate exam, which will be administered in person at the instructor's availability.

### **Extra Credit**

From time to time, an extra credit opportunity may be given to the entire class. On those occasions, a class announcement will be made on how extra points may be earned. No other extra credit opportunities will be given.
